Data will be gathered on the number of CSEC victims successfully transitioned from short-term to long-term care. The USF research study will specifically address the outcomes of the youth in long-term safe home care, identifying what is most successful in their treatment. This will benefit other safe homes, enabling them to learn from successful practices to offer life-skills, including their economic self-

This will reduce recidivism of the CSEC Youth. The TraffickingFree Zone program will offer those convicted of buying sex education "John School" which has proven successful in reducing recidivism significantly.	Data will be gathered on the number of CSEC victims successfully transitioned from short-term to long-term care. The TraffickingFree Zone program in each county will collect data on the number of people going through the "John Schools", and survey them as they leave the school about their intention to commit the crime again. Data will also be gathered in each county to determine reductions in demand for buying sex, thus also showing reduction in recidivism of those habitually buying sex.
