On September 28, representatives from Orange County Government City of Orlando, local law enforcement, Florida Abolitionist and the Greater Orlando Human Trafficking Task Force (GOHTTF) publicly met to promote the need to provide shelter and treatment services to adult and adolescent victims of these crimes. As part of that effort, Orange County Government has committed to fund 10 shelter beds for adult victims.

 - The requested funding will support 3 dedicated, residential treatment beds for adolescent males or females, (ages 14 ? 17), who are victims of Commercial Sexual Exploitation. These beds will be located at Aspire?s Oasis Adolescent Campus (OAC), a DCF licensed Level II substance abuse and mental health treatment program. OAC is funded in part by Central Florida Cares Health System, the managing entity for State of Florida funded behavioral health services. The initiative will also enhance the ser

 - The Aspire Human Trafficking Initiative will enhance the services available to adult female victims of human trafficking in the Orange County Human Trafficking Shelter. The initiative will provide intensive wraparound services not funded by Orange County. This includes comprehensive assessment, psychiatric and medical care, and care coordination. Crisis Support/Assessment Specialist will work with nurses to assess each woman?s medical needs, mental status, substance use, risk of harm to self....
