USGS salt intrusion monitoring indicates substantial landward migration of the salt front at the base of the Biscayne Aquifer in South Miami-Dade County. Prinos et al. 2014, USGS Scientific Investigations Report 2014-5025. This ditch in the Model Lands, created by excavating wetlands for fill to construct an adjacent road, has no water control structures to prevent drainage of the surrounding wetlands or salt intrusion.
