Hurricane Irma flooded 430 homes in Bonita and effected 4,755 residences in Bonita Springs. These projects will re-direct stormwater that has inundated the Imperial River watershed back to its historic watershed in the Cocohatchee south of Bonita Springs. Reducing the volume of water the Imperial River has to convey during high rainfall events and thereby reducing the risk of flooding. This project includes the construction of 2 southern flow-ways and installation of gated structures.
