Pasco County receives frequent intense rainstorms that can cause localized flooding to occur. During a tropical storm or hurricane event, the situation has been much more widespread and intense compared to localized flooding that occurs during seasonal rainstorms. The project will reduce structure and street flooding through the construction of addition of two large storm-water ponds and minor drainage improvements. In total the pond areas provide over 200 acre-feet of additional storage volume.
