Greenhead Road Paving Improvements consist of the construction of 4.15 miles of new asphalt roadway from SR 77 to Fox Pond Rd. The existing road is unpaved and is a major feeder road that traverses between SR 77 and Porter Pond Rd. Greenhead Rd provides access to the Econfina Creek Water Management Area, consisting of 5 parks, and experiences significant traffic due to the recently completed NFWMD springs projects, including Williford Springs which has approximately 20,000 visitors per year.
