shall prepare an annual report which must include a description, based on annual reporting by schools, of student access to and participation in fine arts courses, the number and certification status of educators providing instruction in the courses, and the manner in which schools are providing the core curricular content for fine arts established in the Next Generation Sunshine State Standards.

Section 2. Paragraph (d) is added to subsection (3) of section 1008.34, Florida Statutes, to read:

#### Amendment No. 1

(d) Contingent upon funding provided in the General
Appropriations Act and upon State Board of Education approval of
a statewide, standardized end-of-course assessment for each fine
arts course, the grade of a school comprised of any of grades
kindergarten through grade 12 shall include up to 10 bonus
points, as determined by the Department of Education, for the
participation rate and the performance of students who are
enrolled in fine arts courses, which are visual arts, music,
