

A bill to be entitled

An act relating to the Florida Statutes; amending ss. 11.2421, 11.2422, 11.2424, and 11.2425, F.S.; adopting the Florida Statutes 2014 and designating the portions thereof that are to constitute the official law of the state; providing that the Florida Statutes 2014 shall be effective immediately upon publication; providing that general laws enacted during the 2013 regular session and prior thereto and not included in the Florida Statutes 2014 are repealed; providing that general laws enacted during the 2014 regular session are not repealed by this adoption act; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 11.2421, Florida Statutes, is amended to read:

11.2421 Florida Statutes 2014 ~~2013~~ adopted.—The accompanying revision, consolidation, and compilation of the public statutes of 2013 ~~2012~~ of a general and permanent nature, excepting tables, rules, indexes, and other related matter contained therein, prepared by the Office of Legislative Services under the provisions of s. 11.242, together with corrections, changes, and amendments to and repeals of provisions of Florida Statutes 2013 ~~2012~~ enacted in additional

 36 permanent nature enacted by the State or by the Territory of
 37 Florida at or prior to the 2013 regular ~~March 14-28, 2012,~~
 38 ~~special~~ legislative session, and every part of such statute, not
 39 included in Florida Statutes 2014 ~~2013~~, as adopted by s.
 40 11.2421, as amended, or recognized and continued in force by
 41 reference therein or in ss. 11.2423 and 11.2424, as amended, is
 42 repealed.

43 Section 3. Section 11.2424, Florida Statutes, is amended
 44 to read:

45 11.2424 Laws not repealed.—Laws enacted at the 2014 ~~2013~~
 46 regular session are not repealed by the adoption and enactment
 47 of the Florida Statutes 2014 ~~2013~~ by s. 11.2421, as amended, but
 48 shall have full effect as if enacted after its said adoption and
 49 enactment.
