However, a child eligible under this paragraph ceases 22 to be eligible if his or her family income exceeds 200 percent 23 of the federal poverty level.

24 (f) Priority shall be given next to a child who is younger than 13 years of age from a working family that is economically 25 disadvantaged. A child who is eligible under this paragraph 26 whose sibling is enrolled in the school readiness program under 27 paragraph (c) shall be given priority over other children who 28 29 are eligible under this paragraph. However, a child eligible under this paragraph ceases to be eligible if his or her family 30 31 income exceeds 200 percent of the federal poverty level.


