



Total Grant Aid in 2013 Dollars by Type of Grant, 1993-94 to 2013-14




State Grant Aid per Full-Time Equivalent (FTE) Undergraduate Student by State, 2012-13




Average 2014-15 In-State Tuition and Fees at Public Four-Year Institutions by State




Five-Year Percentage Change in Inflation-Adjusted Tuition and Fees, Public Four-Year Institutions, 2009-10 to 2014-15

Goals

- Increasing educational opportunity and attainment
- More students enroll in college and earn degrees or certificates
- Families and students face less financial strain paying for college

Criteria for effective aid

- Simplicity, predictability, and transparency
- Targeting students whose behavior and outcomes will change
- Supporting both access and academic progress / success

Goal: simple and predictable

Issues:

- Multiple state grant programs
- Decentralized determination of individual awards
 (About half the states allow institutions to determine awards.)
- Timing

Goal: Targeting aid to minimize unmet need

- Significant unmet need among middle-income and particularly low-income students
- More small grants or fewer large grants?
- States with more grant aid extend the funding higher up the income scale.

Supplementing Pell

- Pell (2015-16) = \$5,775 EFC; Florida tuition = \$6,400
- Average FSAG grant (\$1,100) + Pell covers tuition and fees (but not living expenses).
- Pell brings lower income students up to same level (But \$0 EFC up to \$24,000—even though not same ability to pay).
- Higher EFCs have more ability to pay even after considering Pell Grant – less unmet need.
- Adding FSAG to Pell raises recipients above some not receiving either.
- Consider distribution of state appropriations and merit aid

Supporting success

- Defining full-time:
- Students enrolled for 15 credit hours pay more but don't receive extra federal or state grant aid
- Immediate rewards for things students can control
- Credits completed vs. GPA
- Time to degree
- Academic progress in college vs. pre-college achievement

A broader view

- Appropriations that lower tuition for all provide significant subsidies all along the income scale.
- Living expenses require immediate outlays—but it is forgone earnings, not food and housing, that are real costs.
- Biggest student debt problems are among noncompleters.






2013-14 Program Expenditures

FSAG: Initial Eligibility

- File the FAFSA
- Expected Family Contribution (EFC) is less than or equal to the maximum EFC set by OSFA
- \$200 remaining need after all other aid (not loans)

Institutions determine:

- Student met general eligibility for state aid
- Awards within statutory range \$200 to \$2,610



Definition of Need

Need = COA - EFC - Other Aid

- <u>COA</u> (Cost of Attendance) varies per institution and per student
- <u>EFC</u> (Expected Family Contribution) derived from student data in the Free Application for Federal Student Aid (FAFSA)
- Other Aid federal, state, institutional, waivers, and other non-merit programs

FSAG: Renewal Requirements

- · General eligibility requirements for state aid
- Minimum 2.0 GPA
- Earn the required hours each term:
 - FSAG Public and FSAG Career Education
 - · 12 credit hours for each term for full-time enrollment;
 - 9 credit hours for three-quarter-time enrollment; or
 - 6 credit hours for half-time enrollment.
 - FSAG Private and FSAG Postsecondary
 - 12 credit hours for each term the award was received.

A student who does not meet the annual minimum number of credit hours required for renewal may not receive funding the following academic year.



FSAG: Probationary Process

- If a student does not meet the minimum institutional cumulative GPA, a probationary award may be granted for two semesters or three quarters.
- To be eligible for renewal the following year after probation, the student must have earned the required credits and an institutional cumulative GPA of 2.0 on a 4.0 scale.



FSAG: Otherwise Eligible (OE)

- Otherwise Eligibles (OE) are students who meet all criteria to receive an FSAG award, but were not awarded
- Institutions report OE students on the Disbursement Eligibility Report with a disbursement code of "C99"
- OE student counts are used in the formula to allocate funds for the upcoming year at the institutional level

Florida Work Experience Program (FWEP)

- Created in 1993, to assist students who demonstrate financial need by assigning jobs to earn their grants
 - Work is available on campus, K-12 schools, off-campus with a 30% match from private wages
- Award varies by student up to need
 - (COA EFC Other Aid = Need)
- Lessens loan dependency
- 64 of 143 eligible institutions participate



Florida Work Experience Program (FWEP)

- Institutional Requirements
 - State university or Florida College; or
 - Nonprofit Florida postsecondary education institution that is eligible to participate in either of the FSAG programs; or
 - Educator Preparation Institute



<u>Purpose</u>

- 4. If not, what can we do to enhance affordability?




What is the cost of an undergraduate education at an SUS institution?

Applying for Need-Based Financial Aid

Free Application for Federal Student Aid (FAFSA)

- Marital status
- Dependency status
- Household Info



Expected Family Contribution (EFC)

- The Expected Family Contribution (EFC) is a measure of your family's financial strength and is calculated according to a formula established by U.S. Congress.
- A family's taxed and untaxed income, assets, and benefits (such as unemployment or Social Security) are all considered in the formula. Also considered are family size and the number of family members who will attend college during the year.
- A student's EFC is the same regardless of an institution's Cost of Attendance.
- Student Financial Aid is based on EFC not Family Income.



for Undergraduates within the State University System






Headcount Trend for Pell Recipients in the State University System
