#### Amendment (with title amendment)

Remove lines 18-25 and insert:

- (b) 1. If the minor is not classified as a serious or habitual juvenile offender or committed to a juvenile correctional facility or juvenile prison under chapter 985, the program shall retain the minor's criminal history record for 2 + 5 years after the date the minor reaches 19 years of age, at which time the record shall be expunged unless it meets the criteria of paragraph (2)(a) or paragraph (2)(b).
- 2. A minor described in subparagraph (b)1. may apply to the department to have his or her criminal history record expunged prior to the minor becoming 21 years of age. To be eligible for expunction under this subparagraph, the minor must

790.23 Felons and delinquents; possession of firearms, ammunition, or electric weapons or devices unlawful.—

- (2) This section shall not apply to a person:
- (a) Convicted of a felony whose civil rights and firearm authority have been restored.
- (b) Whose criminal history record has been expunded pursuant to s. 943.0515(1)(b).

790.02 Officer to arrest without warrant and upon probable cause.—The <u>unlicensed</u> carrying of a concealed weapon is declared a breach of peace, and any officer authorized to make arrests under the laws of this state may make arrests without warrant of persons violating the provisions of s. 790.01 when said officer has reasonable grounds or probable cause to believe that the offense of <u>unlicensed</u> carrying <u>of</u> a concealed weapon is being committed.

Section 4. Section 790.053, Florida Statutes, is amended to read:

790.053 Open carrying of weapons.-

weapon pursuant to this chapter may openly carry such firearm or weapon; however, except as otherwise provided by law and in subsection (2), it is unlawful for any other person to openly carry on or about his or her person a any firearm or electric weapon or device. It is not a violation of this section for a person licensed to carry a concealed firearm as provided in s. 790.06(1), and who is lawfully carrying a firearm in a concealed

manner, to briefly and openly display the firearm to the ordinary sight of another person, unless the firearm is intentionally displayed in an angry or threatening manner, not in necessary self-defense.

- (2) A person may openly carry, for purposes of lawful self-defense:
  - (a) A self-defense chemical spray.
- (b) A nonlethal stun gun or dart-firing stun gun or other nonlethal electric weapon or device that is designed solely for defensive purposes.
- (3) Any person violating this section commits a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. 775.083.

Section 5. Subsections (1) and (4) of section 790.25, Florida Statutes, are amended to read:

790.25 Lawful ownership, possession, and use of firearms and other weapons.—

matter of public policy and fact that the possession and carrying of weapons and firearms by law-abiding individuals for lawful purposes, including self-defense, enhances public safety and that it is necessary to promote firearms safety and to curb and prevent the use of firearms and other weapons in crime and by incompetent persons without prohibiting the lawful use in defense of life, home, and property, and the use by United States or state military organizations, and as otherwise now
