Remove lines 1051-1064 and insert:

(c) (4) This <u>sub</u>section <u>does shall</u> not <u>be construed to</u> prohibit prosecution of a person in this state or another jurisdiction for a violation of any law of this state, including a law providing for greater penalties than prescribed in this <u>sub</u>section, for the transmission of child pornography, as <u>defined in s. 847.001</u>, to <u>another any</u> person in this state.

(d) (5) A person is subject to prosecution in this state pursuant to chapter 910 for any act or conduct proscribed by this subsection, including a person in a jurisdiction other than this state, if the act or conduct violates paragraph (b)
