I am the sponsor of <u>HB 31 Relating to High School Athletics</u>. The bill would provide requirements regarding fees & contest receipts collected by FHSAA. It would provide that a school may join FHSAA as full-time member or on per-sport basis. It would prohibit FHSAA from taking retributory or discriminatory action against specified schools. Finally, it authorizes the Commissioner of Education to identify other associations in compliance with the provisions.

establish requirements for eliciting a student's medical history and performing the medical evaluation required under this paragraph, which shall include a physical assessment of the student's physical capabilities to participate in interscholastic athletic competition as contained in a uniform preparticipation physical evaluation and history form. The evaluation form shall incorporate the recommendations of the American Heart Association for participation cardiovascular screening and shall provide a place for the signature of the practitioner performing the evaluation with an attestation that each examination procedure listed on the form was performed by the practitioner or by someone under the direct supervision of the practitioner. The form shall also contain a place for the practitioner to indicate if a referral to another practitioner was made in lieu of completion of a certain examination procedure.
