I am pleased to be the prime sponsor of HM 417, entitled "Article V Convention for Congressional Term Limits." If passed, the memorial will constitute a formal application to the United States Congress under Article V of the U.S. Constitution to call a Convention of the States with the sole agenda of proposing an amendment to the U.S. Constitution that limits the number of terms that a person may be elected to the United States House of Representatives and the United States Senate, respectively. At least 34 state legislatures must pass a resolution or memorial calling for an Article V Convention of the States, which Congress must then call. If such a convention were to propose a congressional term limits constitutional amendment, at least 38 states must ratify the amendment in order for it to become part of the Constitution.

Congressional representatives and senators have no incentive to limit their own terms, and even many who campaigned on a term limits pledge have succumbed to "Potomac Fever" and never pushed the initiative once elected. We need to limit the terms of congressional representatives and senators so that long term career survival is no longer their main focus, and so they can focus instead on the real problems facing everyday Americans. The forced injection of new talent and energy into Congress will also make it more responsive to the people its members are supposed to represent. HM

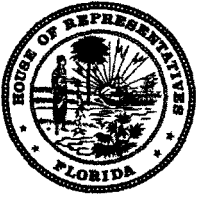
