The department shall use student 35 performance data in subsequent postsecondary courses to 36 determine the appropriate examination scores and courses for which credit is to be granted. Minimum scores may vary by 37 subject area based on available performance data. In addition, 38 39 the department shall identify such courses in the general 40 education core curriculum of each state university and Florida College System institution. 41
