Dear Chair Bileca:

I am writing to respectfully request that **HB 67 – Classified Advertisement Websites**, be placed on the agenda of the *Government Operations Subcommittee* at your earliest convenience. This proposed bill designates safe-haven facilities for classified advertisement websites. The term "safe-haven facility", means a secure location opened to the public for the purpose of conducting a sales transaction involving an item or a service that was offered for sale on a classified advertisement website. The bill promotes the safety of individuals who may fall prey to criminals when they meet to exchange goods for cash. It is intended help deter crimes and provide greater safety throughout the state. The number of safe-haven facilities will be based upon the population size of each county.
