SUPERMAJORITY VOTE REQUIRED TO IMPOSE, AUTHORIZE, RAISE, OR LOWER STATE TAXES OR FEES.—Prohibits the legislature from imposing, authorizing, raising, or lowering a state tax or fee except through legislation approved by a two-thirds vote of each house of the legislature in a bill containing no other subject.
