

Milestones


1999 Resource Allocation Model adopted by the State Board of Community Colleges

2016

- January
 - Funding model revision workgroups formed from college business officers.
- February
 - Internal discussion about changes on the District Cost Differential (DCD) and including actual tuition and fees, other fees and dual enrollment revenue.
- · May:
 - Ongoing discussion regarding changes to the funding model.
- June
 - Discuss efforts to strengthen and modernize the model with the Council of Presidents.
- August
 - Identified key changes to the model with Council of Presidents Steering Committee.
- December
 - Council of Presidents concur with Department's changes to strengthen and modernize model.




Funding Formula Components



- Adult High School


Apprenticeship


District Workforce Education: Total Operating Funds by Source




Current Tuition Policies

- Section 1009.22, Florida Statutes
- Career Certificate Cost
 - Standard Tuition of \$2.33 per contact hour
 - Out-of-state fee of \$6.99 per contact hour
 - Residency determination is required to decide whether the student must pay the out-of-state fee in addition to tuition
- Adult General Education
 - Rate of \$30 per term or \$45 per half year
- Districts may vary the standard tuition rate by 5 percent above or below




Postsecondary Career and Technical Education FTE Enrollment History





Adult General Education (Literacy, Diploma) FTE Enrollment History






District Workforce Education Workload Model

Workload Funding Model Elements

Weighted FTE

- Actual FTE only
- Estimates or projections are not used for the model
- Three-year Average
- For 2018-19 model, will use 2014-15 through 2016-17 FTE

District Cost Differential

Used to adjust the calculated workload-based funding need


Supplemental Factors

- Adults with Disabilities Workforce Education Program (s. 1004.935)
- High School Equivalency testing
- Services for students with disabilities
- Minimum funding level adjustment

Allocation of Workforce Development Funds


- Current Policy for District Allocations
 - BASE FUNDING + ADJUSTMENT
- In recent history, the funding model has been used periodically to make adjustments to the base funding provided to institutions.





2017-18 Allocation Models Used by Legislature

- The workload funding model was used to allocate new funds and to re-allocate a small percentage of the workforce development funds as follows:
 - Reductions to districts with a current allocation of 115% or more above the state funding need
 - Reductions to districts with a current allocation of 102% or more above the state funding need
 - Allocation of new funds and the funds from the reductions to:
 - Increase the funding level to a minimum of 93% of state funding need
 - Ensure all districts with an appropriation level below state funding need received a minimum increase of 0.5%.
