SUMMARY ANALYSIS

The bill creates the Sunshine Scholarship Program (SSP). SSP is designed to assist eligible students attending a Florida College System (FCS) institution with tuition. A student's tuition will be funded at 100 percent for up to 72 credit hours for an associate degree program and 120 credit hours for a baccalaureate degree program. The SSP does not cover fees, textbooks, or other college-related expenses.

To be eligible for SSP, a student must:

- Be a state resident for tuition purposes.
- Have an annual household income equal to or less than \$125,000.
- Be accepted and enroll in a FCS institution.
- Enroll in at least 30 credit hours per academic year.
- Maintain a cumulative grade point average of 2.5 on a 4.0 scale

Upon completion of their program of study, or disenrollment, the student must live and work in Florida for the same length of time they received SSP. The total SSP award, plus interest, must be repaid if the student fails to comply with requirements for residing and working in the state after competition of his or her program of study.

The State Board of Education (SBE) is given rulemaking authority to administer the SSP which will subsequently be administered by the Florida Department of Education (DOE).

The fiscal impact to the state is indeterminate, yet potentially significant. See FISCAL SECTION.

The bill has an effective date of July 1, 2018.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. EFFECT OF PROPOSED CHANGES:

Present Situation

Currently, students attending a FCS must pay the college each semester for tuition, fees, textbooks, or other college-related expenses. The average cost for tuition at an FCS institution is \$80.63 per credit hour for an associate degree program and \$91.79 per credit hour for a baccalaureate degree program. When mandatory fees are included with tuition, the average cost is \$106.84 per credit hour for an associate degree program and \$121.57 per credit hour for a baccalaureate degree program. These figures are for tuition and mandatory fees only and do not include other college-related expenses such as room, board, textbooks, etc. that, when combined, add up to a total cost of attendance.

FCS students may receive financial aid from the federal or state government through programs such as: 1) Federal Pell Grants, 2) Florida Student Assistance Grants, and 3) Florida Bright Futures Scholarships.

Pell Grant¹

Federal Pell Grants are need-based grants which are awarded to undergraduate students who have not earned a bachelor's or a professional degree. These grants do not require repayment. The grant amount awarded to a student can change annually. The maximum grant award is \$5,920 for the 2017–18 award year (July 1, 2017 to June 30, 2018). The amount awarded is dependent upon the student's financial need, the tuition cost, and whether the student is full-time or part-time. A student is no longer eligible to receive a grant once a baccalaureate degree or first professional degree has been earned, or 12 semesters of eligibility has been used.

Florida Student Assistance Grant²

The Florida Student Assistance Grant (FSAG) Program is a need-based grant program available to degree-seeking, resident, undergraduate students who demonstrate substantial financial need and are enrolled in participating postsecondary institutions. The grant is available to students who attend Florida state universities, FCS institutions, or eligible private, non-profit, four-year colleges and universities located in Florida..

Additionally, the Florida Public Postsecondary Career Education Student Assistance Grant (FSAG-CE) is available to students who attend eligible and participating FCS institutions or career centers operated by district school boards.

Florida Bright Futures Scholarship Program³

The Bright Futures Scholarship Program (Bright Futures) is a merit-based scholarship funded through the Florida lottery to provide scholarships to undergraduate students. Bright Futures consists of four tiers of scholarships including:

- Florida Academic Scholars Award (FAS);⁴
- Florida Medallion Scholars Award (FMS);⁵
- Gold Seal Vocational Scholars Award (GSV);6 and
- Gold Seal CAPE Scholars Award (GSC)⁷

Effect of Proposed Changes

The bill creates the Sunshine Scholarship Program (SSP). SSP is designed to assist eligible students attending a FCS institution with tuition. A student's tuition will be funded at 100 percent for up to 72 credit hours for an associate degree program and 120 credit hours for a baccalaureate degree program. The SSP does not cover fees, textbooks, or other college-related expenses.

To be eligible for SSP, a student must:

- Be a state resident for tuition purposes.
- Have an annual household income equal to, or less than, \$125,000.
- Be accepted and enroll in a FCS institution.
- Enroll in at least 30 credit hours per academic year.
- Maintain a cumulative grade point average of 2.5 on a 4.0 scale

Upon completion of his or her program of study, or disenrollment, the student must live and work in Florida for the same length of time they received SSP. The total SSP award, plus interest, must be repaid if the student fails to comply with the requirements for residing and working in the state after completion of his or her program of study.

The SBE is given rulemaking authority to administer the SSP which will subsequently be administered by the Florida DOE.

B. SECTION DIRECTORY:

Section 1. Creates section 1009.894, F.S. establishing the SSP which provides 100 percent of tuition for Florida residents pursuing an associate degree or career certificate from a FCS institution.

Section 2. Provides an effective date of July 1, 2018.

		The latest Florida College System FTE Enrollment estimate for FY 2017-18 indicates that 16,232 full-time-equivalent students will enroll in upper division degree programs, and 216,310 FTE will enroll in lower division degree programs. It is unknown what portion of these students would qualify based on the credit hour, income threshold, and grade point average requirements set forth in the bill. It is also not known how the policy would change enrollment behavior for current and future students; therefore, the cost to the state is indeterminate, yet potentially significant.

Section 1. Section 1009.894, Florida Statutes, is created to read:

1009.894 Sunshine Scholarship Program.-

- There is established the Sunshine Scholarship Program to be administered by the Department of Education. The Sunshine Scholarship Program shall provide funding for 100 percent of an eligible student's tuition at a Florida College System institution for up to 72 credit hours for an associate degree program and 120 credit hours for a baccalaureate degree program.
- To be eligible to receive a scholarship pursuant to (2) this section, a student must:
 - Be a resident for tuition purposes, as defined in s. (a)

- (b) Have a total annual household income equal to or less than \$125,000.
- (c) Be accepted by and enroll in a Florida College System institution.
 - (d) Enroll in at least 30 credit hours per academic year.
- (3) Upon completion of his or her program of study or upon disenrollment from the Florida College System institution, the student must reside and work within the state for the same period of time he or she received funds from the program. If the student does not reside and work within the state for the specified period, the student must repay the total amount awarded, plus an annual interest rate equal to the federal student loan interest rate in effect when the student entered the program. This subsection does not apply to a student who enlists in the United States Armed Forces.



SUMMARY ANALYSIS

Currently, a state university student must pay an excess hour surcharge for each credit hour in excess of the number of credit hours required to complete the baccalaureate program in which the student is enrolled.

The bill exempts from the surcharge first-time-in-college students who complete the requirements for their baccalaureate degree program within 4 years. In addition, the bill modifies the excess hour surcharge for students enrolled in a degree program designated by the Board of Governors as an area of strategic emphasis in a science, technology, engineering, mathematics, or health discipline. Specifically, for such students an excess hour surcharge equal to 100 percent of the tuition rate will be assessed for each credit hour attempted in excess of 120 percent of the credit hours required to complete the baccalaureate degree. The excess hours surcharge for all other students will continue to be assessed when the student exceeds 110 percent of the degree program.

The bill could result in a loss of revenue for institutions from students who take excess credit hours beyond the requirements for a baccalaureate degree program. See FISCAL SECTION.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. EFFECT OF PROPOSED CHANGES:

Present Situation

Currently, state university students must pay an excess hour surcharge for credit hours exceeding baccalaureate degree program completion requirements.¹ The Legislature's intent is to encourage each undergraduate student who enrolls in a state university to complete the student's respective baccalaureate degree program in the most efficient way possible while providing for access to additional college coursework. Therefore, a policy was enacted that provides incentives for efficient baccalaureate degree completion.²

Specifically, the excess hour surcharge is effective for students who enter a state university for the first time and maintain continuous enrollment as follows:³

- For the 2009-2010 and 2010-2011 academic years, an excess hour surcharge equal to 50 percent of the tuition rate for each credit hour in excess of 120 percent.⁴
- For the 2011-2012 academic year, an excess hour surcharge equal to 100 percent of the tuition rate for each credit hour in excess of 115 percent.⁵
- For the 2012-2013 academic year and thereafter, an excess hour surcharge equal to 100 percent of the tuition rate for each credit hour in excess of 110 percent.⁶

All credit hours taken at the state university from which the student is enrolled are included when calculating the number of hours taken by a student, including:⁷

- Failed courses.⁸
- Courses that are dropped after the university's advertised last day of the drop and add period.⁹
- Courses from which a student withdraws, except as provided in subsection (4).¹⁰
- Repeated courses, except repeated courses for which the student has paid the full cost of instruction as provided in s. 1009.285, F.S.¹¹

In addition, all credit hours earned at another institution and accepted for transfer by the state university and applied toward the student's baccalaureate degree program are included in the calculation.¹²

Credit hours earned under the following circumstances are not calculated as hours required to earn a baccalaureate degree:13

- College credits earned through an articulated accelerated mechanism identified in s. 1007.27, F.S.¹⁴
- Credit hours earned through internship programs.¹⁵
- Credit hours required for certification, recertification, or certificate programs.¹⁶
- Credit hours in courses from which a student must withdraw due to reasons of medical or personal hardship.¹⁷
- Credit hours taken by active-duty military personnel. 18
- Credit hours required to achieve a dual major taken while pursuing a baccalaureate degree.¹⁹
- Remedial and English as a Second Language credit hours.²⁰
- Credit hours earned in military science courses that are part of the Reserve Officers' Training Corps (ROTC) program.²¹

Each state university and Florida College System institution must implement a process for notifying students regarding the excess credit hour surcharge and the notice must be provided upon a student's initial enrollment in the institution. Additionally, the notice must be provided a second time by a state university when a student has earned the credit hours required to complete the baccalaureate degree program in which the student is enrolled. The notice must include a recommendation that each student who intends to earn credit hours at the institution in excess of the credit hours required for the baccalaureate degree program in which the student is enrolled meet with his or her academic advisor.²²

Effect of Proposed Changes

The bill exempts from the surcharge first-time-in-college students who complete the requirements for their baccalaureate degree program within 4 years. In addition, the bill modifies the excess hour surcharge for students enrolled in a degree program designated by the Board of Governors as an area of strategic emphasis in a science, technology, engineering, mathematics, or health discipline.²³ Specifically, for such students an excess hour surcharge equal to 100 percent of the tuition rate will be charged for each credit hour attempted in excess of 120 percent (rather than 110 percent) of the credit hours required to complete the baccalaureate degree.

B. SECTION DIRECTORY:

Section 1. Amends s. 1009.286, F.S., exempting first-in-time college students completing their baccalaureate degree within 4 years from paying excess hour surcharges, and applying the surcharge for each credit hour in excess of 120 percent rather than 110 percent for students enrolled in a degree program designated by the Board of Governors as an area of strategic emphasis in a science, technology, engineering, mathematics, or health discipline.

Section 2. Provides an effective date of July 1, 2018.

university for the first time and maintain continuous enrollment as follows:

- (a) For the 2009-2010 and 2010-2011 academic years, an excess hour surcharge equal to 50 percent of the tuition rate for each credit hour in excess of 120 percent.
- (b) For the 2011-2012 academic year, an excess hour surcharge equal to 100 percent of the tuition rate for each credit hour in excess of 115 percent.
- (c) For the 2012-2013 academic year and thereafter, an excess hour surcharge equal to 100 percent of the tuition rate for each credit hour in excess of 110 percent. However, for students enrolled in a degree program designated by the Board of Governors as an area of strategic emphasis in a science, technology, engineering, mathematics, or health discipline there is an excess hour surcharge equal to 100 percent of the tuition rate for each credit hour in excess of 120 percent.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. EFFECT OF PROPOSED CHANGES:

Present Situation

With the approval of its district board of trustees, a Florida College System institution may change the name of the institution as listed in s. 1000.21(3), F.S., and use the designation "college" or "state college" if it has been authorized to grant baccalaureate degrees and has been accredited as a baccalaureate-degree-granting institution by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC).¹ A district board of trustees that approves the use of the designation "college" or "state college" must seek statutory codification of the name change during the next regular legislative session.²

Florida Keys Community College has met the statutory requirements for a name change.³ The college is accredited by the SACSCOC to award associate degrees⁴ and a Bachelor of Applied Science in Supervision and Management.⁵

On January 6, 2016, Florida's State Board of Education unanimously approved Florida Keys Community College's proposal to offer its first baccalaureate degree at their monthly meeting in Tallahassee.⁶ On December 4, 2016, the SACSCOC accredited the college to offer the Bachelor of Applied Science in Supervision and Management effective January 2017.⁷

Effect of Proposed Changes

The bill amends s. 1000.21(3)(h), F.S., changing the name of "Florida Keys Community College" to "College of the Florida Keys". The college has complied with the statutory requirements for name changes.




