29	Museum of Black History Task Force for the purpose of providing
30	recommendations to the division for the planning, construction,
31	operation, and administration of a Florida Museum of Black
32	History. The museum shall be a multipurpose facility capable of
33	generating self-sustaining revenues, with archival research and
34	storage facilities, meeting rooms, full service banquet
35	facilities that include a kitchen capable of serving at least
36	250 people at a single event, and a performing arts theater that
37	shall be made available for private events.
38	(2) The task force shall be composed of nine members.
39	Three members shall be appointed by the Governor, three members
