Florida Families Act; Designates act as "Florida Families Act"; authorizes clerk of circuit court to collect filing fee for domestic partner registrations; establishes requirements for domestic partnership; provides that act does not preempt authority of county or municipality to enact domestic partnership ordinance unless in conflict with act. Effective Date: July 1, 2014

HB 441 by Lee (Identical SB 426)

Food Deserts; Provides income tax credit for certain businesses that sell nutrient-dense food items in areas designated as food deserts; provides for amount of credit; requires application; requires DOR & DACS to review & make recommendations to Legislature regarding continuation of credit; provides penalties for fraudulent claims for credit; authorizes rulemaking; provides for applicability. Effective Date: July 1, 2014

HB 443 by Lee

Florida Catastrophic Storm Risk Management Center; Specifies duties of Florida Catastrophic Storm Risk Management Center; requires annual discussion forums; creates & specifies membership of discussion forum panel; specifies powers & duties of panel; provides for per diem & travel expenses; provides for reports; limits liability. Effective Date: July 1, 2014

HB 445 by Nuñez (Identical SB 494)

Time Limitations; Eliminates time limitations to prosecution of specified criminal offenses relating to lewd or lascivious battery, molestation, conduct, or exhibition against child if victim was younger than 16 years of age at time of offense; provides for applicability. Effective Date: July 1, 2014

HB 447 by Castor Dentel

Optional Medical Payments for Prenatal Care; Revises eligibility criteria for pregnant women to qualify for medical assistance payments. Effective Date: July 1, 2014

HB 449 by Clelland (Identical SB 540)

Sharks; Prohibits possession, sale, trade, purchase, shipping, barter, exchange, or distribution of shark fins; provides criminal penalties & assessment of specified fees & costs by FWCC; requires destruction of seized shark fins; provides for applicability; authorizes FWCC to adopt rules. Effective Date: July 1, 2014

HB 451 by Fitzenhagen, Williams, A. (Identical SB 548)

Bullying; Provides that person who willfully, maliciously, & repeatedly harasses or cyberbullies another person commits offense of bullying; provides that person who willfully, maliciously, & repeatedly harasses or cyberbullies another person & makes credible threat to that person commits offense of aggravated bullying. Effective Date: October 1, 2014

HB 453 by Watson, B. (Identical SB 410)

Fair Housing Act; Provides that person aggrieved by discriminatory housing practice may file civil action to enforce rights granted & protected by Fair Housing Act without filing complaint with FCHR or without regard to status of complaint filed with FCHR; provides that if FCHR or local agency has obtained a conciliation agreement with consent of person aggrieved by discriminatory housing practice in response to complaint filed with FCHR, filing civil action to enforce rights is prohibited except to enforce terms of such conciliation agreement. Effective Date: July 1, 2014

HB 455 by Eagle

Restitution for Juvenile Offenses; Requires child's parent or guardian, in addition to child, to make restitution for damage or loss caused by child's offense; provides for payment plans in certain circumstances; authorizes parent or guardian to be absolved of liability for restitution in certain circumstances; specifies that DCF is not guardian for purposes of restitution; removes duplicative provisions authorizing court to require parent or guardian to be responsible for any restitution ordered against child. Effective Date: July 1, 2014

HB 457 by Harrell (Identical SB 520)

Pub. Rec./Dental Workforce Surveys; Provides exemption from public records requirements for information contained in dental workforce surveys submitted by dentists or dental hygienists to DOH; provides exceptions to exemption; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: upon becoming a law

HB 459 by Schwartz (Identical SB 436)

Payment for Services by Licensed Psychologists; Adds licensed psychologists to list of health care providers who are protected by limitations period from claims for overpayment being sought by health insurers or HMOs; adds licensed psychologists to list of health care providers who are subject to limitations period for submitting claims to health insurers or HMOs for underpayment; adds licensed psychologists to list of health care providers who are eligible for direct payment for medical services by health insurer. Effective Date: July 1, 2014

HB 461 by Powell

Prosecution of Juveniles; Revises age-based criteria & offenses for which discretionary direct file of information against child may be made in adult court; prohibits filing of information on child otherwise eligible if it is child's first offense unless there are compelling reasons; requires such reasons to be stated in writing; provides criteria for state attorney to determine whether to file information; requires state attorney to file written explanation when information is filed; provides criteria for consideration of child's request to return to juvenile justice system. Effective Date: July 1, 2014

HB 463 by Reed

Background Screening; Authorizes DHSMV to share reproductions of driver license images with DOH & AHCA for specified purposes; adds additional qualifying offenses to background screening requirements; revises applicability of background screening requirements for certain service providers who must register with DOE's Division of Vocational Rehabilitation; revises information required for vendors submitting employee fingerprints; revises criteria for exemption from disqualification for employee under certain conditions; requires simultaneous submission of photographic image & electronic fingerprints to Care Provider Background Screening Clearinghouse; requires employer to follow certain criminal history checks procedures & include specified information regarding referral & registration of employee for electronic fingerprinting. HB 465 by Jones, M.

Hepatitis C Testing; Requires specified persons to be offered Hepatitis C testing; provides for followup health care for persons with positive test result; requires DOH to adopt rules; provides for applicability with respect to Hepatitis C testing by health care practitioners. Effective Date: July 1, 2014

HB 467 by Rodríguez, J. (Similar HB 369, Identical SB 334)

Sentencing in Capital Felonies; Requires that advisory sentence of death be made by unanimous recommendation of jury after defendant's conviction or adjudication of guilt; requires court to instruct jury that, in order for jury to recommend to court that death penalty be imposed, jury must find that sufficient aggravating circumstances exist which outweigh any mitigating circumstances; requires court to instruct jury that each aggravating circumstance must be proven beyond reasonable doubt by unanimous vote; requires that court provide special verdict form for each aggravating circumstance. Effective Date: July 1, 2014

HB 469 by Raschein (Identical SB 478)

Move Over Act; Requires driver to move over for utility service vehicle on roadside. Effective Date: July 1, 2014

HB 471 by Boyd (Compare HB 291, SB 462, SB 496, SB 542)

Insurance; Defines "authorized inspection agency"; revises & provides provisions relating to the state boiler inspection program; revises original appointment & renewal fees related to certain insurance representatives; revises specified time period applicable to certified examination that must be filed by foreign or alien insurer applying for certificate of authority; prohibits an insurance agency from conducting insurance business at location without designated agent in charge; provides agency license requirements; revises qualifications for approval as mediator by DFS; provides grounds for department to deny an application, or suspend or revoke approval of mediator or certification of neutral evaluator; authorizes department to adopt rules; revises date by which title insurance agencies & certain insurers must annually submit specified information to OIR; requirements relating to contractual liability policies that insure warranty associations. HJR 473 by Diaz, J.

Municipal Property Tax Exemption; Proposes amendment to s. 3, Art. VII of State Constitution to allow Legislature, by general law, to exempt from taxation property owned by municipality.

HB 475 by Goodson (Similar SB 532)

Disclosure of Sexually Explicit Images; Prohibits individual from intentionally & knowingly disclosing private, sexually explicit image of identifiable person, through attached personal identifiers, links, or facial recognition for purpose of harassment of such person if individual knows or should have known person depicted in sexually explicit image did not consent to such disclosure & objects to such disclosure; provides enhanced penalties for violations by persons 18 years of age or older involving victims younger than 16 years of age; provides exceptions; requires court to order that person convicted of violation of be prohibited from having contact with victim & requires penalties for violation of order run consecutively to penalties for original violation. Effective Date: October 1, 2014

HM 477 by Clarke-Reed (Similar SM 464)

Preclearance Coverage Formula of Voting Rights Act of 1965; Urges Congress to revise preclearance coverage formula set forth in Section 4 of Voting Rights Act of 1965.

HB 479 by Hager (Identical SB 582)

Substance Abuse Services; Requires sober house transitional living home to annually register with DCF; requires background screening of certain personnel; provides for fees & penalties; prohibits certain advertising; authorizes DCF to conduct inspections & deny, suspend, or revoke registration of home. Effective Date: July 1, 2014

HB 481 by Cruz

Pub. Rec./Voter Registration; Limits applicability of public records exemptions related to voter registration applicants & voters to information obtained for purpose of voter registration; provides exemption from public records requirements for date of birth of voter registration applicants & voters; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: July 1, 2014

HB 483 by Cruz (Identical SB 174)

Autism; Requires physician to refer minor to appropriate specialist for screening for autism spectrum disorder under certain circumstances; requires certain insurers & HMOs to provide direct patient access to specialist for screening for or evaluation or diagnosis of autism spectrum disorder; requires certain insurance policies & HMO contracts to provide minimum number of visits per year for screening for or evaluation or diagnosis of autism spectrum disorder. Effective Date: July 1, 2014

HB 485 by Raburn

Sexual Misconduct with Students by Authority Figures;

Designates act as "Stop Harassing Underage Teens Act"; provides for reclassification of specified sexual offenses committed against students by an authority figure; provides for severity ranking of offenses; provides for application of severity ranking chart of Criminal Punishment Code. Effective Date: October 1, 2014

HB 487 by Raburn

Agricultural Industry Certifications; Requires DOACS to annually provide to SBE & DOE industry certifications for farm occupations to be placed on industry certification funding lists; defines industry certification as part of career education programs; requires rules for implementing industry certification process for farm occupations; requires placement on funding lists to determine annual funding distributions to school districts & postsecondary institutions. Effective Date: July 1, 2014

HB 489 by Spano

Residential Property Sales/Subsurface Rights; Requires sellers of residential property to provide written notification to prospective buyers of intent to retain subsurface rights; provides form for such notification; provides definitions; provides method to rescind contract; identifies jurisdiction; provides penalties for willful violation of notification requirement. Effective Date: July 1, 2014

HB 491 by Pafford (Similar SB 408)

Infectious Disease Elimination Pilot Program; Designates act as "Miami-Dade Infectious Disease Elimination Act (IDEA)"; requires DOH to establish pilot program in Miami-Dade County; provides for administration by DOH or designee; provides that distribution of needles & syringes under pilot program does not violate Florida Comprehensive Drug Abuse Prevention & Control Act or any other law; provides conditions under which pilot program staff member or participant may be prosecuted; requires report by OPPAGA. Effective Date: July 1, 2014

HB 493 by Baxley

State Parks; Authorizes historical monuments to be erected & maintained within state park system; requires legislative approval for such monuments. Effective Date: upon becoming a law

Residency of Candidates and Public Officers; Requires candidate or public officer required to reside in specific geographic area to have only one domicile at a time; provides factors that may be considered when determining residency; provides exceptions for active duty military members.
