**HB 91 by Roberson, K.** (Compare SB 248)

**State Ombudsman Program;** Reorganizes long-term ombudsman services; provides duties of Office of State Long-Term Care Ombudsman & State Long-Term Care Ombudsman Council; provides conditions under which representative of office could be found to have conflict of interest; provides immunity from liability for representative of office; requires long-term care facilities to provide representatives of office with access to facilities, residents, & records for certain purposes; provides for office to coordinate ombudsman services with Disability Rights Florida. Effective Date: July 1, 2014

**HB 93 by Reed** (Identical SB 178)

**Disability Awareness;** Requires district school board to provide disability history & awareness instruction in K-12 public schools; provides for presenters who have disabilities to augment instruction; requires school to establish disability history & awareness advisory council. Effective Date: upon becoming a law

**HB 95 by Clarke-Reed** (Similar SB 210)

**Juvenile Civil Citations;** Requires that law enforcement officer, upon making contact with juvenile who admits having committed misdemeanor, issue civil citation in certain circumstances. Effective Date: July 1, 2014

**HB 97 by Magar** (Similar SB 142)

**Dentists & Dental Hygienists;** Revises definition of term "contract"; requires that contract with governmental contractor for health care services include provision allowing voluntary contribution toward certain dental laboratory work; provides that contribution may not exceed actual amount of dental laboratory charges. Effective Date: July 1, 2014

**HB 99 by Edwards, Hood, Baxley, Pilon, Stewart**

**Sentencing for Controlled Substance Violations;** Designates act "Elizabeth Dillinger Act"; revises criminal penalties for persons engaged in illegal trafficking of prescription drugs involving specified quantities of oxycodone or hydrocodone. Effective Date: July 1, 2014

**HB 101 by Jones, M.**

**Habitual Traffic Offender Designations;** Provides for removal of habitual traffic offender designation upon proof of compliance with specified statutory provisions. Effective Date: upon becoming a law

**HB 103 by Jones, M.** (Identical SB 112)

**Possession or Discharge of a Firearm or Destructive Device During Commission of Specified Offenses;** Provides that sentencing court may elect not to impose minimum term of imprisonment for person convicted of certain offenses during which person actually possessed or discharged firearm or destructive device if court finds that certain specified criteria are met; requires sentencing court that elects not to impose mandatory minimum sentence for relevant offense to make specific findings to support its decision to impose lesser term. Effective Date: July 1, 2014

**HB 105 by Berman, Edwards, Moskowitz, Pafford, Saunders, Schwartz, Stark, Torres** (Identical SB 220)

**Florida Civil Rights Act;** Prohibits discrimination on basis of pregnancy in specified establishments; prohibits employment discrimination on basis of pregnancy, childbirth, or related medical conditions; prohibits discrimination on basis of pregnancy by labor organizations, joint labor-management committees, employment agencies, or in licensing. Effective Date: July 1, 2014

**HB 107 by Stark**

**Driver Licenses;** Provides for person adjudicated mentally or physically incompetent to surrender his or her driver license to court; directs court to send license with record of adjudication to DHSMV. Effective Date: July 1, 2014

**HB 109 by Gibbons** (Similar SB 280)

**Pub. Rec./Participants in Treatment-Based Drug Court Programs;** Exempts from public records requirements information from initial screenings for participation in treatment-based drug court program, substance abuse

screenings, behavioral health evaluations, & subsequent treatment status reports regarding a participant or person considered for participation in treatment-based drug court program; provides for future repeal & legislative review of exemption; provides statement of public necessity. Effective Date: upon becoming a law

**HB 111 by Gibbons** (Similar SB 256)

**Pub. Rec./Forensic Behavioral Health Evaluations;** Creates exemption from public records requirements for forensic behavioral health evaluation filed with court; defines "forensic behavioral health evaluation"; authorizes release of such evaluations; provides statement of public necessity. Effective Date: upon becoming a law

**HB 113 by Fresen** (Similar SB 66)

**Discretionary Sales Surtaxes;** Authorizes county to levy surtax up to specified amount for benefit of Florida College System institution & state university in county pursuant to ordinance conditioned to take effect upon approval in referendum; requires ordinance to include plan for use of proceeds; provides referendum requirements & procedures; requires that proceeds from surtax be transferred into specified account & managed in specified manner; establishes oversight board with specified duties, responsibilities, & requirements relating to expenditure of surtax proceeds; provides for appointment of members of oversight board; requires that board of trustees of each institution receiving surtax proceeds prepare annual plan for submission to oversight board for approval; provides that state funding may not be reduced because institution receives surtax funds; provides for scheduled expiration of surtax. Effective Date: upon becoming a law

**HB 115 by Pigman** (Similar SB 318)

**Public Meetings/University Direct Support Organization;** Provides exemption from public meeting requirements for portion of meeting of board of directors of university DSO, or of executive committee or other committees of board, at which identity of donor or prospective donor, proposal seeking research funding from organization, or plan or program for initiating or supporting research is discussed; provides for review & repeal of exemption; provides statement of public necessity. Effective Date: October 1, 2014

**HB 117 by Ray**

**Public Retirement Plans;** Specifies applicability of ch. 185, F.S., to certain consolidated governments; provides that consolidated government that has entered into interlocal agreement to provide police protection services to municipality within its boundaries is eligible to receive premium taxes reported for municipality; authorizes municipality receiving police protection services to enact an ordinance levying tax as provided by law; including certain consolidated governments under provisions authorizing imposition of state excise tax on casualty insurance premiums covering certain property. Effective Date: July 1, 2014

**HJR 119 by Rader**

**Real Property Rights of Aliens Ineligible for Citizenship;** Proposes amendment to s. 2, Art. I of State Constitution to delete provision authorizing laws that regulate or prohibit ownership, inheritance, disposition, & possession of real property by aliens ineligible for citizenship.

**HB 121 by Raburn** (Compare HB 207, SB 312)

**Agricultural Lands Classification;** Provides that participation in water retention program may be considered nonincome-producing use under certain circumstances. Effective Date: July 1, 2014

**HB 123 by Schwartz** (Identical SB 120, Compare CS/SB 108)

**Fees and Costs in Guardianship Proceedings;** Provides that fees & costs incurred by attorney who has rendered services to ward in compensation proceedings are payable from guardianship assets; provides that expert testimony is unnecessary in proceedings to determine compensation for attorney or guardian; provides that court may appoint guardian ad litem to minor if necessary to protect minor's interests in settlement; provides that settlement of minor's claim is subject to certain confidentiality provisions; directs that examining committee be paid from state funds as court-appointed expert witnesses if petition for incapacity is dismissed; requires that petitioner reimburse state for expert witness fees if court finds petition to have been filed in bad faith. Effective Date: upon becoming a law

**HB 125 by Schwartz** (Similar CS/SB 108, Compare SB 120)

**Pub. Rec./Claim Settlement on Behalf of Minor or Ward;** Creates exemption from public records requirements for records relating to settlement of claim on behalf of minor or ward; authorizes guardian ad litem, ward, minor, & minor's attorney to inspect guardianship reports & court records relating to settlement of claim on behalf of minor or ward, upon showing of good cause; authorizes court to direct disclosure & recording of amendment to report or court records relating to settlement of claim on behalf of ward or minor, in connection with real property or for other purposes; provides statement of public necessity; provides for contingent effect. Effective Date: on the same date that HB 123 or similar legislation takes effect if such legislation is adopted in the same legislative session or an extension thereof and becomes law

**HB 127 by Brodeur, Santiago, Hood, Hutson** (Identical SB 208)

**Motorsports Entertainment Complexes;** Provides for monthly distribution of specified amount of sales tax revenue to complex certified as motorsports entertainment complex by DEO; revises definition of term "motorsports entertainment complex"; revises requirements for certification of facility as motorsports entertainment complex; specifies that DEO may certify only one motorsports entertainment complex; authorizes Auditor General

to verify expenditure of specified distributions & to notify DOR of improperly expended funds. Effective Date: July 1, 2014

#### **HB 129 by Raburn**

**Insurance;** Requires Citizens Property Insurance Corporation to submit biannual report on number of residential sinkhole policies issued & declined; provides legislative findings; establishing Citizens Sinkhole Stabilization Repair Program for sinkhole claims; provides program components; specifies corporation's liability with respect to sinkhole claims; requires corporation to offer specified deductible amounts for sinkhole loss coverage. Effective Date: July 1, 2014

#### **HB 131 by Hager, Raschein, Berman, Diaz, J., Kerner, Pafford, Rader, Renuart** (Identical SB 250)

**Henry Morrison Flagler Memorial;** Establishes Henry Morrison Flagler Memorial; requires DMS to designate location for memorial in Capitol courtyard & consult with Henry Morrison Flagler Museum regarding construction, installation, & management of memorial; provides for creation of figurative bronze sculpture to be installed in memorial. Effective Date: July 1, 2014

#### **HB 133 by Rogers** (Identical SB 192)

**Legislative Lobbying Expenditures;** Revises term "expenditure" to exclude use of public facility or public property that is made available by governmental entity to legislator for public purpose, to exempt such use from legislative lobbying requirements; provides exceptions when member or employee of Legislature may accept certain expenditures made by lobbyist or principal; provides reporting requirements; requires each house of Legislature to establish rules governing reporting procedures; provides for future expiration & reversion as of specified date of statutory text. Effective Date: July 1, 2014

#### **HB 135 by Kerner**

**Public Records & Public Meetings/Postsecondary Education Executive Search;** Provides exemption from public records requirements for personal identifying information of applicant for president, provost, or dean of state university or Florida College System institution; provides exemption from public meeting requirements for meeting held for purpose of identifying or vetting applicants for president, provost, or dean of state university or Florida College System institution & for portion of meeting held for purpose of establishing qualifications of, or compensation framework to be offered to, potential applicants that would disclose personal identifying information of applicant or potential applicant; requires release of names of specified applicants within certain timeframe; provides for future legislative review & repeal of exemptions; provides statement of public necessity. Effective Date: October 1, 2014

#### **HB 137 by Hudson** (Similar SB 236)

**Edison State College;** Renames Edison State College as "Florida South Western State College." Effective Date: July 1, 2014

#### **HB 139 by Jones, S.**

**Volunteers for Organized Youth Sports and Recreational Programs;** Defines "volunteer" & "youth sports or recreation authority"; expands provisions relating to athletic coaches for independent sanctioning authorities to require youth sports or recreation authorities to conduct specified background screening of all volunteers with any youth athletic team or organized youth recreational program using publicly owned facilities; provides that duty may not be delegated; requires that specified documentation be maintained for specified period by such authorities. Effective Date: July 1, 2014

#### **HB 141 by Powell**

**Florida Enterprise Zone Act;** Revises date of repeal of Florida Enterprise Zone Act. Effective Date: July 1, 2014

#### **HB 143 by Raburn**

**Florida Insurance Guaranty Association;** Revises duties of Florida Insurance Guaranty Association; authorizes association to collect regular & emergency assessments directly from policyholders; clarifies that assessments are not considered premium for premium tax purposes. Effective Date: July 1, 2014

#### **HB 145 by Rogers** (Similar SB 244)

**Specialty License Plates/Sun, Sea, & Smiles;** Creates Sun, Sea, & Smiles license plate; establishes annual use fee for plate; provides for distribution of use fees received from sale of such plates. Effective Date: July 1, 2014

#### **HB 147 by Caldwell** (Similar SB 286)

**Concrete Masonry Education;** Designates act as "Concrete Masonry Education Act; creates Florida Concrete Masonry Education Council, Inc.; provides powers & duties of council; provides for appointment & terms of council's governing board; authorizes council to accept grants, donations, contributions, & gifts; authorizes council to make payments to other organizations; provides for collection of voluntary assessment on concrete masonry units; requires manufacturers who elect to pay assessment to commit to paying assessment for specified period; requires council to adopt bylaws. Effective Date: July 1, 2014

#### **HB 149 by Clarke-Reed**

**School District Educational Programs;** Requires that school district be given specified lead time to plan & budget for implementation of certain new state requirements. Effective Date: July 1, 2017



**HB 151 by Fitzenhagen** (Similar SB 242)

**Security of Protected Consumer Information;** Designates act as "Keeping I.D. Safe (KIDS) Act"; authorizes representative of protected consumer to place security freeze on protected consumer's consumer report or record and provides procedures and requirements with respect thereto; prohibits consumer reporting agency from stating or implying that security freeze reflects negative credit history or rating; requires consumer reporting agency to provide copy of consumer report or record upon request; authorizes consumer reporting agency to charge fees; requires consumer reporting agency to remove security freeze under specified conditions; provides procedure for removal of security freeze; requires written notification upon change of specified information in consumer report or record; requires consumer reporting agency to notify representative & provide specified information if consumer reporting agency violates security freeze; provides penalties & civil remedies; provides written disclosure requirements for consumer reporting agencies. Effective Date: September 1, 2014

**HB 153 by Renuart** (Compare HB 169, SB 224)

**Nicotine Dispensing Devices;** Prohibits gift of sample nicotine dispensing devices to persons under 18 years of age; prohibits selling, delivering, bartering, furnishing, or giving of nicotine dispensing devices to persons under 18 years of age; prohibits persons under 18 years of age from possessing, purchasing, or misrepresenting their age or military service to purchase nicotine dispensing devices; requires certain signage where dealer sells nicotine dispensing devices; requires DBPR to submit number of violations for selling nicotine dispensing devices in annual report. Effective Date: July 1, 2014

**HB 155 by Smith**

**Defense Contracting;** Provides that certain prime contractors may apply to DEO to certify that such contractors may reduce their computation of adjusted federal income by certain amount when awarded prime contract; provides requirements to apply for reduction in computation of income; provides that prime contractor must apply separately for each qualified subcontract award; provides guidelines for DEO to certify award. Effective Date: July 1, 2014

**HB 157 by Rodrigues, R.**

**Pub. Rec./Fracturing Chemical Usage Disclosure Act;** Provides exemption from public records requirements for trade secrets contained within information relating to hydraulic fracturing treatments obtained by DEP's Division of Resource Management in connection with the division's online hydraulic fracturing chemical registry; provides procedures & requirements with respect to the granting of confidential and exempt status; provides for disclosure under specified circumstances; provides for future review & repeal of the exemption; provides statement of public necessity; provides for contingent effect. Effective Date: on the same date that HB 71 or similar legislation takes effect

**HB 159 by Berman**

**Establishment of Mental Health First Aid Training Program;** Requires DCF to establish mental health first aid training program; provides course requirements & requires certification of instructors; provides for expiration of program. Effective Date: July 1, 2014

**HB 161 by Hager** (Identical SB 254, Compare HB 181, SB 276)

**Indecent Exposure;** Increases classification of second & subsequent violations of provision prohibiting unlawful exposure of sexual organs; authorizes arrest without warrant if there is probable cause to believe that person has committed unlawful exposure of sexual organs in violation of specified provisions. Effective Date: October 1, 2014

**HB 163 by Cruz** (Identical SB 206)

**Employment Discrimination;** Designates act as "Helen Gordon Davis Fair Pay Protection Act"; provides legislative findings & intent relating to equal pay for equal work for women; recognizing importance of DEO & FHRC in ensuring fair pay; provides for duties of department & commission; creates Governor's Recognition Award for Pay Equity in Workplace. Effective Date: July 1, 2014

**HB 165 by Cruz** (Identical SB 80)

**Economic Development;** Provides corporate tax credit against state corporate income tax in amount equal to specified percentage of corporation's payments to small business providing goods or services to the corporation; provides qualification criteria; requires corporation & business to submit application to DEO for approval to earn credits; provides procedures & requirements for department approval; specifies amount of tax credit; prohibits tax credits from being carried forward or backward or being transferred or sold; provides criminal & administrative penalties; authorizes DEO & DOR to adopt rules; revises order in which credits against corporate income tax or franchise tax may be taken to include certain credits relating to corporation's execution of business contract with small business; redefines term "adjusted federal income" to include amount of such tax credits. Effective Date: July 1, 2014

**HB 167 by Jones, M.** (Similar SB 70)

**Telemedicine;** Defines "telemedicine services"; prohibits health insurance policy or Medicaid from requiring face-to-face contact between health care provider & patient as prerequisite to coverage or reimbursement for services; clarifies that use of telemedicine technology under supervision of another health care practitioner may not be interpreted as practicing medicine without license; authorizes DOH to adopt rules; requires department to repeal any rule that prohibits use of telemedicine; requires department to conduct study on options for implementing telemedicine for certain services; requires DOH to submit report to Legislature. Effective Date: July 1, 2014

**HB 169 by Artiles, Renuart** (Identical SB 224, Compare HB 153)

**Alternative Nicotine Products;** Prohibits gift of sample alternative nicotine products to persons younger than 18 years of age; prohibits sale, delivery, bartering, furnishing, or giving of alternative nicotine products to persons younger than 18 years of age; prohibits person who is younger than 18 years of age from buying, possessing, or misrepresenting his or her age in order to buy alternative nicotine products; revises contents of signs that must be displayed at locations where alternative nicotine products are available for purchase. Effective Date: July 1, 2014

**HB 171 by Diaz, J.** (Identical SB 308)

**Public Assistance Fraud;** Authorizes DFS to administer oaths & affirmations & issue & serve subpoenas when conducting investigations into public assistance fraud; provides penalty. Effective Date: July 1, 2014

**HB 173 by Adkins**

**Juvenile Justice Education Programs;** Revises requirements for multiagency education plan for students in juvenile justice education programs; revises requirements effective education programs for youth in DJJ programs; revises contract & cooperative agreement requirements for delivery of appropriate education services to youth in DJJ programs; revises requirements for activities to be coordinated by coordinators for juvenile justice education programs; requires that educational program shall be based on each youth's reentry plan & assessed needs; provides requirements for prevention & day-treatment juvenile justice education programs; requires progress monitoring plans for all non-exceptional student students; requires that DOE, in partnership with DJJ, ensure that school districts & juvenile justice education providers develop educational transition plans; requires DOE to establish student performance measures & program performance ratings; requires comprehensive accountability & school improvement process; provides requirements for such process. Effective Date: July 1, 2014

**HB 175 by Steube** (Identical SB 294, Compare SB 292)

**Emergency Communication System;** Revises provisions relating to Emergency Communications Number E911 System; revises provisions for administration, distribution, & use of E911 fee; provides for prepaid wireless E911 fee; revises provisions for accounting, distribution, use, & auditing of Emergency Communications Number E911 System Fund. Effective Date: upon becoming a law

**HB 177 by Steube** (Identical SB 292, Compare SB 294)

**Pub. Rec./Prepaid Wireless E911 Fee;** Provides exemption from public records requirements for specified information received by DOR relating to prepaid wireless E911 fee; authorizes DOR to share such information with Secretary of Management Services & E911 Board; including DOR as additional recipient of specified confidential information relating to wireless service; provides for future legislative review & repeal; provides statements of public necessity; provides for

contingent effect. Effective Date: on the same date that HB 175 or similar legislation takes effect

**HB 179 by Bracy** (Similar SB 150)

**Voter Registration;** Authorizes DHSMV to automatically register to vote or update voter registration record of eligible individual; requires DHSMV to notify individual that certain information gathered for completion of driver license or identification card application, renewal, or change of address is automatically transferred to voter registration application or used to update voter registration record; authorizes applicant to revoke consent to automatically register to vote or update voter registration record; requires that applicant who fails to designate party affiliation be registered without party affiliation. Effective Date: July 1, 2014

**HB 181 by Harrell** (Identical SB 276, Compare HB 161, SB 254)

**Indecent Exposure;** Provides enhanced penalties for third or subsequent indecent exposure violations. Effective Date: July 1, 2014

**HB 183 by Nelson** (Identical HB 55, SB 102)

**Drivers Leaving the Scene of a Crash;** Designates act as "Aaron Cohen Life Protection Act"; requires driver of vehicle involved in crash that results in serious bodily injury to a person to immediately stop vehicle & remain at scene of crash; provides penalties. Effective Date: July 1, 2014

**HB 185 by Danish**

**Gasoline Stations;** Requires self-service gasoline pump inspection decals to contain certain information; provides exception; requires DACS to confirm compliance by specified date; provides for preemption of local regulations pertaining to fueling assistance for certain motor vehicle operators. Effective Date: July 1, 2014

**HB 187 by Passidomo**

**Civil Remedies Against Insurers;** Requires insureds, claimants, or persons acting on their behalf to provide insurer with written notice of loss as condition precedent to statutory or common-law action for third-party bad-faith failure to settle insurance claim; provides that insurer is not liable for claim of bad faith failure to settle claim if certain conditions are met. Effective Date: July 1, 2014

**HB 189 by Boyd**

**Growth Management;** Revising restrictions on initiative or referendum process in regard to local comprehensive plan amendments & map amendments. Effective Date: upon becoming a law

**HB 191 by Jones, S., Berman, Reed**

**Public School Personnel Evaluation;** Delays implementation of personnel evaluation procedures conducted for purposes of awarding contracts & providing performance pay. Effective Date: upon becoming a law

**HB 193 by Nelson** (Similar CS/SB 130, Compare HB 33)

**Use of Deadly Force;** Requires county sheriff or municipal police department to issue reasonable guidelines for operation of neighborhood crime watch programs; provides that guidelines are subject to reasonable exceptions; provides that person who is justified in using force is immune from criminal prosecution & civil action initiated by person against whom force was used; revises definition of term "criminal prosecution"; clarifies that law enforcement agency retains right & duty to fully investigate use of force upon which an immunity may be claimed; provides that any reason, including immunity, used by an aggressor to justify use of force is not available to aggressor. Effective Date: October 1, 2014

**HB 195 by Raburn** (Identical SB 188)

**Biometric Information;** Provides that students & parents have certain rights relating to submission of biometric information; requires school district that collects student biometric information to implement policies governing collection & use of information; requires security of information & notification if security is breached; provides penalties. Effective Date: July 1, 2014

**HB 197 by Stone**

**Qualified Portable Consumer Fuel Containers;** Provides that manufacturers, sellers, & suppliers of qualified portable consumer fuel containers are not liable for injury, death, or loss, subject to specified actions, & not responsible for other relief relating to misuse of qualified portable consumer fuel containers; provides exceptions; provides for award of attorney fees in certain circumstances. Effective Date: July 1, 2014

**HB 199 by Jones, S.** (Identical SB 304)

**College and Career Readiness;** Requires school district to offer high school students college & career readiness course; provides course requirements; requires students to take interest assessment & develop curriculum plan; specifies components of course curriculum & activities. Effective Date: July 1, 2014

**HB 201 by Workman, Eagle, Raschein**

**Flags;** Designates act as "All-American Flag Act"; requires United States flag or state flag that is purchased by state, county, or municipality for public use to be made in United States; provides penalty for willful violations. Effective Date: July 1, 2014

**HB 203 by Raulerson** (Identical SB 260)

**Unaccompanied Youth;** Authorizes certain unaccompanied youth to consent to medical, dental, psychological, substance abuse, & surgical diagnosis & treatment for themselves & for their children in certain circumstances; provides that such consent does not affect Parental Notice of Abortion Act requirements. Effective Date: July 1, 2014

**HB 205 by Rodríguez, J.** (Compare HB 35, HB 51, CS/SB 84)

**Resident Status for Tuition Purposes;** Revises certain residency requirements for tuition purposes for dependent children; prohibits denial of classification as resident for tuition purposes based on certain immigration status; revises provisions relating to required documentation as evidence of residency; provides additional persons who shall be classified as residents for tuition purposes; provides fee exemption for students with certain immigration status; authorizes certain fee & tuition waivers. Effective Date: July 1, 2014

**HB 207 by Raburn** (Identical SB 312, Compare HB 121)

**Agriculture;** Provides that participation in water retention program may be considered nonincome-producing use under certain circumstances; provides that certain uses of diesel fuel & farm equipment by qualified agricultural producers are exempt from sales & use tax; provides that certain items in agricultural use, certain nets, gas or electricity used for agricultural purposes, growth enhancers or performance enhancers for cattle, & feeds for poultry, ostriches, & livestock used by agricultural producer are exempt from sales & use tax; provides criteria for qualified agricultural producer; authorizes qualified agricultural producer to apply for agricultural sales & use tax exemption certificate from DOR; authorizes DOR to adopt rules, establish oversight board, direct staff, & charge fees; provides tools to determine eligibility of qualified agricultural producer. Effective Date: July 1, 2014

**HB 209 by Fitzenhagen** (Identical SB 296)

**Carrying Concealed Weapon or Concealed Firearm;** Provides exemption from criminal penalties for carrying concealed weapon or concealed firearm when complying with mandatory evacuation order during declared state of emergency. Effective Date: July 1, 2014

**HB 211 by Reed** (Identical SB 306)

**Community Health Workers;** Specifies duties & activities of community health workers; creates Community Health Worker Task Force within Florida College System institution or state university; requires DOH to provide administrative support & services; provides membership & duties of task force; requires members of task force to elect chair & vice chair; provides that task force members serve without compensation & are not entitled to reimbursement for per diem or travel expenses; requires that task force meet at least quarterly; authorizes task force members to meet in person or by teleconference or other electronic means; specifies number of members required for

quorum; requires task force to submit report to Governor & Legislature by specified date; provides for future repeal of task force. Effective Date: upon becoming a law

**HB 213 by Santiago** (Identical SB 288)

**Underground Facility Damage Prevention & Safety;** Revises definition of term "premark"; revises notification & marking procedures for proposed excavation or demolition; creates noncriminal infraction for failure by excavator to notify member operator of planned start date & time of specified excavation; deletes certain notification exemptions; revises excavators' premarking requirements; revises definition of term "high-priority subsurface installation"; authorizes member operator to deem owned or operated underground pipeline or facility high-priority subsurface installation; requires excavator to notify member operator of current & accurate contact information; revises requirement to report certain infractions; authorizes settlement of incident by payment of fine. Effective Date: July 1, 2014

**HB 215 by Broxson**

**Federal Write-in Absentee Ballot;** Authorizes absent uniformed services voters & overseas voters to use federal write-in absentee ballot in any state or local election; provides that eligible elector may vote on any ballot measure in election using federal write-in absentee ballot; revises minimum requirements for Department of State rules used in determining what constitutes valid vote on federal write-in absentee ballot involving manual recounts. Effective Date: July 1, 2014

**HB 217 by Rehwinkel Vasilinda**

**Streamlined Sales and Use Tax Agreement;** Specifies certain facilities that are exempt from transient rentals tax; deletes application of brackets for calculation of sales & use taxes; revises criteria establishing circumstances under which taxes on sale of prepaid calling arrangements are due; limits \$5,000 cap on discretionary sales surtax to sale of certain vehicles and homes; provides criteria to determine situs of certain sales; requires purchasers of direct mail to use direct-mail forms; revises exemptions from sales & use tax for food & medical products; provides for computation of taxes due based on rounding instead of brackets; provides amnesty for uncollected or unpaid sales & use taxes for sellers who register under Streamlined Sales & Use Tax Agreement; provides for adoption of emergency rules; repeals provisions pertaining to taxation of mail-order sales. Effective Date: January 1, 2015

**HB 219 by Richardson** (Similar SB 204)

**Tax Incentives;** Requires EDR to prepare annual state tax incentive revenue report to be provided to Legislature; provides for certification & distribution of report. Effective Date: July 1, 2014

**HB 221 by Richardson, Saunders** (Identical SB 240)

**Sexual Orientation Change Therapy;** Defines "sexual orientation change therapy"; prohibits person who is licensed under ch. 458, ch. 459, ch. 490, or ch. 491, F.S., from providing

sexual orientation change therapy to person who is younger than 18 years of age. Effective Date: July 1, 2014

**HB 223 by Combee**

**Professional Geology;** Revises requirements for professional geologist licensure applicants to take licensure examination; provides for registration of geologists in training; provides requirements for geologist in training applicants to take fundamentals of geology portion of licensure examination; exempts registered geologists in training seeking licensure as professional geologist from retaking fundamentals of geology portion of licensure examination. Effective Date: July 1, 2014

**HB 225 by Perry**

**Child Safety Devices in Motor Vehicles;** Revises child restraint requirements for children younger than specified age & less than specified height; requires such persons to use separate carrier or integrated child seat. Effective Date: January 1, 2015

**HB 227 by Kerner** (Identical SB 326)

**Victims of Wrongful Incarceration;** Provides that wrongfully incarcerated person who was convicted & sentenced to death on or before December 31, 1979, is exempt from certain application procedures for compensation if special prosecutor issues nolle prosequi after reviewing defendant's conviction; provides alternative procedures for applying for compensation; requires claimant to file application with Attorney General's office within specified time; requires application to include certain information & documents; provides that claimant is entitled to compensation if all requirements are met; provides for future repeal of provisions. Effective Date: July 1, 2014

**HB 229 by Santiago** (Compare SB 272)

**Water and Wastewater Utility Systems;** Requires certain review of private activity bond allocations; extends tax exemptions to certain investor-owned utilities; exempts certain resellers of water from PSC regulations; establishes criteria for quality of service determinations; authorizes commission to adopt rules & create a utility reserve fund; provides for automatic increase or decrease of approved rates; revises provisions relating to rate case expenses; provides for certain loans, grants, & deposits to for-profit privately owned or investor-owned systems. Effective Date: July 1, 2014

Withdrawn prior to introduction

**HB 231 by Brodeur** (Identical SB 330)

**Admissions Tax;** Revises professional sporting events that are exempt from admissions tax. Effective Date: July 1, 2014

**HM 233 by Nuñez** (Similar SM 332)

**Federal Government Shutdown/Payment of Federal Taxes;** Urges Congress to waive payment of all federal taxes that become due & are owed during shutdown of Federal Government.

**HB 235 by Combee**

**Department of Economic Opportunity;** Requires DEO to create web page accessible through its Internet website that provides certain information; provides purpose of web page; requires DEO to collect all local business information available to DEO; requires DEO to request relevant local government to provide any otherwise unavailable information; requires local governments to provide notice of changes in information collected by department; authorizes local government entities to provide summary that includes certain information for DEO's web page. Effective Date: July 1, 2014

**HB 237 by Gibbons** (Similar SB 336)

**Impact Statements;** Requires that, upon request of member of Legislature, OPPAGA prepare racial & ethnic impact statement describing anticipated effects of proposed legislation or proposed state constitutional amendment on certain minority persons; provides requirements pertaining to statement. Effective Date: July 1, 2014

**HB 239 by Saunders**

**Prohibited Discrimination;** Creates "Florida Competitive Workforce Act"; prohibits discrimination based on sexual orientation & gender identity or expression; defines terms; provides exceptions for constitutionally protected free exercise of religion. Effective Date: July 1, 2014

**HB 241 by Gaetz**

**Developments of Regional Impact;** Deletes certain exemptions for dense urban land areas. Effective Date: July 1, 2014

**HM 243 by Gaetz**

**Renewable Fuel Standard;** Urges Congress to repeal the Renewable Fuel Standard established under the Energy Independence & Security Act of 2007.

**HB 245 by Jones, S.**

**Charter Schools;** Provides for transfer of school funds from charter school to another public school under certain circumstances; requires charter school to submit report to district school board with reasons for student reassignment under certain circumstances; limits reasons for student reassignment. Effective Date: July 1, 2014

**HB 247 by Jones, S.** (Identical SB 328)

**Trafficking in Illegal Drugs;** Provides that specified mandatory minimum term of imprisonment & specified fine no longer

apply upon first conviction, but only on second or subsequent conviction, of person who knowingly sells, purchases, manufactures, delivers, or brings into this state, or who is knowingly in actual or constructive possession of, specified quantity of certain designated illegal drugs. Effective Date: July 1, 2014

**HB 4001 by Rehwinkel Vasilinda**

**Nuclear and Integrated Gasification Combined Cycle Power Plants;** Repeals provisions for cost recovery mechanisms for siting, design, licensing, & construction of nuclear & integrated gasification combined cycle power plants, including mechanisms that promote utility investment in, & allow for recovery in electric utility rates of certain costs of, such plants. Effective Date: July 1, 2014

Energy & Utilities Subcommittee; Government Operations Appropriations Subcommittee; Regulatory Affairs Committee

**HB 4003 by Williams, A., Stafford, Jones, M., Watson, C.** (Identical SB 116)

**Use of Deadly Force in Defense of a Person;** Repeals provisions relating to home protection & use of deadly force, which created presumption of fear of death or great bodily harm in certain circumstances & provided that person has no duty to retreat & has right to stand his or her ground & meet force with force in certain circumstances; conforms provisions. Effective Date: upon becoming a law

Criminal Justice Subcommittee; Justice Appropriations Subcommittee; Judiciary Committee

**HB 4005 by Gaetz** (Similar SB 314)

**Fireworks;** Repeals provisions relating to testing & approval of sparklers & registration of manufacturers, distributors, wholesalers, & retailers of sparklers; repeals provisions relating to sale & use of fireworks; repeals provisions relating to bond of licensees; conforms provisions. Effective Date: upon becoming a law

Insurance & Banking Subcommittee; Government Operations Appropriations Subcommittee; Regulatory Affairs Committee

**HB 4007 by Diaz, J.**

**Duties of Department of Agriculture and Consumer Services;** Repeals requirement that DACS represent Florida in Southern States Energy Compact. Effective Date: July 1, 2014

Energy & Utilities Subcommittee; Agriculture & Natural Resources Subcommittee; Regulatory Affairs Committee

**HB 4009 by Artiles** (Similar SB 144)

**Traffic Infraction Detectors;** Repeals provisions relating to installation & use of traffic infraction detectors to enforce specified provisions when driver fails to stop at traffic signal. Effective Date: upon becoming a law

**HB 4011 by Rehwinkel Vasilinda**

**Death Penalty;** Deletes provisions providing for death penalty for capital felonies; deletes associated provisions, including provisions relating to representation in death penalty cases, capital collateral representation, jurors in capital cases, prohibiting imposition of death sentence on defendant with mental retardation, determination of whether to impose sentence of death or life imprisonment for capital felony or capital drug trafficking felony, issuance of warrant of execution, stay of execution of death sentence, proceedings when person under sentence of death appears to be insane, proceedings when person under sentence of death appears to be pregnant, grounds for death warrant, execution of death sentence, prohibition against reduction of death sentence as result of determination that method of execution is unconstitutional, sentencing orders in capital cases, regulation of execution, transfer to state prison for safekeeping before death warrant issued, return of warrant of execution issued by Governor, sentence of death unexecuted for unjustifiable reasons, & return of warrant of execution issued by Supreme Court. Effective Date: July 1, 2014

**HB 4013 by Stark**

**Health Insurance;** Deletes provisions that exempt for specified period certain nongrandfathered health plans from rate review or approval by OIR; deletes provisions relating to grounds for disapproval of rates that do not apply to nongrandfathered health plans. Effective Date: upon becoming a law

**HCR 8001 by Berman, Castor Dentel, Clarke-Reed, Cruz, Dudley, Edwards, Kerner, Pafford, Pritchett, Rader, Raschein, Rogers, Saunders, Schwartz, Slosberg, Stark, Stewart, Torres, Waldman, Watson, C.** (Identical SCR 68)

**Equal Rights for Men and Women;** Ratifies proposed amendment to U.S. Constitution relating to equal rights for men & women.
