**Single-Gender Public School Programs;** Provides requirements for district school board when establishing genderspecific elementary, middle, or high school; requires school administrative & instructional personnel to participate in professional development; provides accountability requirements. Educator Certification; Provides requirements for certain instructional personnel who supervise or direct preservice field experience; revises acceptable means of demonstrating mastery of general knowledge, subject area knowledge, & professional preparation & education competence; revises components of competency-based professional development certification & education competency program; repeals study to compare performance of certain certificateholders; revises certain requirements for renewal or reinstatement of professional certificate. **Public Meetings/University Direct-Support Organization;** Provides exemption from public meeting requirements for any portion of meeting of board of directors of university DSO, or of executive committee or other committees of board, at which proposal seeking research funding from organization or plan or program for initiating or supporting research is discussed; provides for review & repeal of exemption; provides statement of public necessity. Effective Date: October 1, 2014

**Background Screening;** Revises requirement relating to background screening of instructional personnel in virtual instruction programs; provides additional offenses that determine ineligibility for educator certification or employment; revises requirements for submission, retention, search, & reporting of fingerprints of educational personnel & contractual personnel; provides for FDLE participation in national retained print arrest notification program. Effective Date: July 1, 2014

Effective Date: July 1, 2014
