

Effective Date: October 1, 2014

**Sexual Offenders;** Prohibits certain conditional releasees, probationers, or community controllees from viewing, accessing, owning, or possessing any obscene, pornographic, or sexually stimulating material, regardless of such material's relevance to offender's deviant behavior pattern. Effective Date: October 1, 2014

Threatened Use of Force; Applies provisions relating to use of force in defense of persons, property, etc., to threatened use of force; provides that person is not justified in threatened use of force to resist arrest by law enforcement officer; provides that person is eligible to apply for & receive certificate of eligibility for expunction, notwithstanding eligibility requirements, if charging document in case is not filed or is dismissed because it is found that person acted in lawful self-defense pursuant to provisions related to justifiable use of force. Effective Date: upon becoming a law

**HB 97 by Magar, Spano, Campbell** (Similar SB 142, Compare HB 869, SB 710)

**Dentists & Dental Hygienists;** Revises definition of term "contract"; requires that contract with governmental contractor for health care services include provision allowing voluntary contribution toward certain dental laboratory work; provides that contribution may not exceed actual amount of dental laboratory charges. Effective Date: July 1, 2014

CS/HB 99 by Criminal Justice Subcommittee, Edwards, Hood, Baxley, Campbell, Dudley, Pilon, Stewart, Wood (Similar CS/SB 360)

**Controlled Substances;** Provides that person who engages in certain acts involving specified quantities of hydrocodone or oxycodone commit specified offenses; conforms provisions. Effective Date: July 1, 2014

Criminal Justice Subcommittee: Favorable With Committee Substitute; Justice Appropriations Subcommittee: Favorable; Judiciary Committee: Favorable

CS/HB 113 by Education Committee, Fresen, Diaz, M., Gibbons, Gonzalez, Raschein, Rodríguez, J. (Similar SB 66)

Discretionary Sales Surtaxes; Authorizes county to levy surtax up to specified amount for benefit of Florida College System institution & state university in county pursuant to ordinance conditioned to take effect upon approval in referendum; requires ordinance to include plan for use of proceeds; provides referendum requirements & procedures; requires that proceeds from surtax be transferred into specified account & managed in specified manner; establishes oversight board with specified duties, responsibilities, & requirements relating to expenditure of surtax proceeds; provides for appointment of members of oversight board; requires that board of trustees of each institution receiving surtax proceeds prepare annual plan for submission to oversight board for approval; provides that state funding may not be reduced because institution receives surtax funds; provides for scheduled expiration of surtax. Effective Date: upon becoming a law

Finance & Tax Subcommittee: Favorable; Education Committee: Favorable With Committee Substitute; Appropriations Committee: Favorable HB 123 by Schwartz (Identical SB 120, Compare CS/SB 108)

Fees and Costs in Guardianship Proceedings; Provides that fees & costs incurred by attorney who has rendered services to ward in compensation proceedings are payable from guardianship assets; provides that expert testimony is unnecessary in proceedings to determine compensation for attorney or guardian; provides that court may appoint guardian ad litem to minor if necessary to protect minor's interests in settlement; provides that settlement of minor's claim is subject to certain confidentiality provisions; directs that examining committee be paid from state funds as court-appointed expert witnesses if petition for incapacity is dismissed; requires that petitioner reimburse state for expert witness fees if court finds petition to have been filed in bad faith. Effective Date: upon becoming a law
