Corporate Income Tax; Adopts 2015 version of Internal Revenue Code; incorporates reference to recent federal act into state law for purpose of defining "adjusted federal income"; revises treatment by this state of certain depreciation & expensing of assets that are allowed for federal income tax purposes; authorizes DOR to adopt emergency rules; provides retroactive applicability. Effective Date: upon becoming a law

Adoption and Foster Care; Revises requirements for agreements between DCF & specified entities; revises roles & responsibilities of caregivers, department, CBCs, & agency staff; requires postadoptive assistance to be offered; provides purpose of adoption incentive program; directs DCF to establish adoption incentive program for certain agencies; requires DCF to conduct assessment of lead agencies' performance; requires DCF to negotiate outcome-based agreements; requires DCF to allocate incentive payments; provides amounts payable to qualifying adoptive employee; requires Governor to present adoption achievement awards; authorizes DSO established by Office of Adoption & Child Protection to accept donations from private sources for recipients of awards; provides requirements for intercountry adoptions. HB 7027 by Rules, Calendar & Ethics Committee, Eisnaugle (Identical SB 700)

Official Florida Statutes; Adopts Florida Statutes 2015 & designates portions thereof that are to constitute official law of state; provides that Florida Statutes 2015 shall be effective immediately upon publication; provides that general laws enacted during August 7-11, 2014, special session & prior thereto & not included in Florida Statutes 2015 are repealed; provides that general laws enacted during 2015 regular session are not repealed by this adoption act. Effective Date: on the 60th day after adjournment sine die of the session of the Legislature in which enacted

Florida Statutes/General; Deletes provisions that have expired, become obsolete, had their effect, served their purpose, or been impliedly repealed or superseded; replaces incorrect crossreferences & citations; corrects grammatical, typographical, & like errors; removes inconsistencies, redundancies, & unnecessary repetition in statutes; improves clarity of statutes & facilitates their correct interpretation; confirms restoration of provisions unintentionally omitted from republication in acts of Legislature during amendatory process & removes genderspecific references applicable to human beings from Florida Statutes without substantive change in legal effect. Effective Date: on the 60th day after adjournment sine die of the session of the Legislature in which enacted
